Privileges include access to all dining facilities and events at the Club. There are three dining facilities to choose from. Our Grill Room is right inside the entry way and has a casual atmosphere where you can find families, business meetings and friends gathering and is the preferred place of dining for lunch and dinner. There is also an outside patio for lunch and dinner service as well. The Main Dining Room is more formal, however there is not usually a set dress code unless we have a big event. Upstairs we have our newly renovated Panther Den with both inside and outside seating available and a separate bar menu. Also available are two additional private dining and meeting spaces.

Resident Clubhouse Membership (Promotion!)

Initiation Fee: **\$500**

\$55 Monthly Dues + **\$46.88** Cap. Assessment + **\$75** Food & Bev. Minimum

Privileges are the same as listed above.

Available to **NEW** residents in Panther Creek, Panther Creek West, The Reserve, Iron Gate, Savannah Pt & Bogey Hills. Available to members who purchased a home within last 60 days. This is a 12 month "Resident" rate. After 12 months regular "Clubhouse" dues apply.

The Clubhouse is open for lunch and dinner Wednesdays-Saturdays. The Panther Den is open Wednesday- Friday 3pm-11pm, Saturday 11am-11pm and Sundays from 11am-6pm with a select menu.

Initiation Fee \$3,000

\$1,299 Monthly Dues + **\$468.75** Monthly Capital Assessment

Available to corporations, general partnerships, limited liability companies and sole proprietorships.

- There shall be 1 primary member who must maintain an Equity Golf Membership.
- The primary member may designate up to a maximum of 4 member designees who are owners, officers or employees of the corporation, general partnership, limited liability company or sole proprietorship.
- Up to 2 of the designees may be full Golf Members and 2 may be Social Members (maximum of 3 golf memberships per business account, including primary member)
- Privileges for the Primary and 2 Golf Members include all of the Club's facilities and amenities to include the championship 18-hole golf course, driving range, practice facilities, fitness center, aquatic center, tennis, clubhouse, dining and all social events and activities. The 2 Social Member designees may play up to 3 rounds of golf per month. These rounds are available at a cost of 1/2 the green fees. Each additional designee will enjoy the privileges applicable to the category in which they join.
- In addition, the primary Business Member can name up to 8 additional Clubhouse Members at 50% of the cost of the monthly clubhouse membership dues. These clubhouse designees have privileges of clubhouse, dining, and all social events and activities.

Non-Resident Membership

\$500 Initiation Fee/ **\$101** Monthly Dues

Available to applicants who do not reside full or part-time or own, lease, rent, occupy or otherwise possess or maintain a residential property or dwelling within 100 miles of the city limits of Springfield.

Privileges include full access to all of the Club's facilities and amenities to include the championship 18-hole golf course, driving range, practice facilities, swimming, tennis, clubhouse, dining and all social events and activities. Subject to \$190 Annual Range Fee.

- Requires “owning” a home at least 200 miles from Springfield, IL
- Must live in remote/vacation home at least 5 concurrent months of the year
- Renting a vacation home or remote home does not qualify
- Would require providing Panther Creek CC with information and address of secondary location.
- 7 months at full membership dues of Equity or Non-Equity Golf
- 5 months at \$102/month (5 months at remove location)
- Subject to golf fees (driving range, cart fees)
- If you do come back for the holidays or any time during the 5 months away for a brief visit, you are allowed to use the Club.

The 5 months of reduced dues are billed from November 1- March 31.

I hereby certify that I qualify for the “Snow-Bird” Membership, specifically that I own or rent concurrently for a minimum of 5 months per year, a home at least 200 miles from Springfield, IL. I understand that I will be billed October 31– February 28th at the reduced rate (regardless of the actual months that I am away) and billed the full membership rate March 31st- September 30th.

Equity Certificate

All Equity memberships require the purchase of a refundable Equity Certificate for \$500. Your Equity Certificate is included in the price of the initiation fee.

Panther Creek By-laws state:

“The Club shall have no capital stock and shall be composed of members rather than shareholders. All property and assets of the Club are vested in the Club, which is a corporate entity. The Club shall have Equity and Non-equity (for certain categories of membership) members. An Equity Member shall have paid a fee in addition to an initiation fee which payment shall entitle the Equity Member to participate in the governance of the Club with the right to vote on all matters submitted to Equity Members and to serve as a governor or officer of the Club, or the chairperson of any committee. All other members shall pay an initiation fee and other fees and charges as provided for in these By-laws, but shall have no right to vote and may not serve as an officer of the Club.”

All memberships are subject to monthly Capital Assessments as follows:

Annual Driving Range Fees

All golf memberships are subject to an Annual Driving Range Fee:

- Platinum Equity Golf: **\$190**
- Junior Equity Golf (31-39): **\$190**
- Junior Golf (21-30): **\$190**

Optional:

- Social Members: **\$380**
- Business Members: **\$950**

Social Members who wish to use the driving range have the option of paying an annual driving range fee of \$380. Business memberships may also include the driving range for an annual payment of \$950.

Food & Beverage Minimums

Clubhouse & Resident Clubhouse memberships require a minimum of \$75 to be spent on food and beverage items at the Club each month. Food and beverage charges at any of our dining venues, including pool snack bar, main dining room, banquet room, grill room, and panther den, count towards the required minimum. Dining charges from other clubs, even if billed through Panther Creek via reciprocal arrangements, do not count toward the required minimum spending, nor do sales tax and gratuities.

- Clubhouse & Resident Clubhouse Members Food & Beverage Monthly Minimum: **\$75**

Finance Charges

The Club bills monthly for all member charges. A member will be assessed a finance charge on any amounts not paid by the last day of the month. Checks must be received in the Business Office by the last day of the month to be credited for that month. The interest rate on past due balances is established by the Board of Governors and is subject to change.

I (we) have read these terms and conditions of membership, and understand and accept them. I (we) also agree to abide by the Club By-Laws and Rules, and understand that current copies of these documents are available on the Club's website (or in print if requested). I (we) agree to pay all Club invoices by the end of the month following the date of the invoice, plus interest on past dues balances, together with collection cost and reasonable attorney's fees incurred by the Club in collecting amounts due. Further, I (we) agree that if the account is sent to collections, I (we) will be assessed an additional 35% of the outstanding balance.

Statements & Billing

Statements are available online through the member login section of the Panther Creek website (mailed paper statements are available upon request only), and an email is sent out during the first week of every month as notification that the prior month statement is finalized and available online.

Members' payments are due upon receipt of that email notification (or the mailed paper statement), but must be received no later than the last day of the month to avoid a finance charge.

A letter will be automatically mailed to all members who miss the month end deadline to remind them of the unpaid balance. If payment is then not received within 15 additional days, they are sent a second reminder of their late payment and given 15 more days to pay or have their membership suspended. Although the Board does not enjoy having to follow such procedures, it is necessary to maintain the financial stability of the Club.

Member Only Website Login & Online Statements

Create your member account:

Click on the Members Login link on the Home Page of the website. Then click on: "Member Registration" You then need to enter the information requested and click the register button.

Access your member statement:

You will receive an email by the 5th of each month to notify you that statements from the previous month are finalized and ready for your viewing.

After logging in, click on Member Statements.

You will see that you are brought to the current month's activity. Adjust the statement period to the prior month to see the prior month's complete statement that is due by the current month end. Example: You log in on August 5 to see your July 31 statement balance that is due by August 31. The initial screens brings you to your August activity, so you will need to adjust the statement period back to 07/01 – 07/31 to see only the July charges that are due by the end of August.

You may print your statement for your records or to mail in with your check if you wish.

Q: Can I sponsor a friend for membership?

A: Yes, sponsoring new members is a privilege and a responsibility of all Members of the club.

Q: How is the Club governed?

A: The government and administration of the affairs and the property of the Club shall be vested in a Board of Governors which are elected by the Equity Members of the Club.

Q: What are the hours of the Business office?

A: Monday through Friday 9:00am - 4:30pm.

Q: How do I find out about Club events?

A: All of our events, outings and activities can be found in detail via email, Facebook, on our website and in monthly newsletters. In order to receive complete and up to date information on these events, be sure that we have your current email address. Add us as a friend on Facebook at: www.facebook.com/panthercreekcountryclub1

Q: Do I need to make a reservation to dine?

A: It is strongly recommended and greatly appreciated to make reservations for lunch or dinner at the Club and for social events. However, walk-ins are always welcome.

Q: Can Members reserve a private room or banquet room for special events and parties?

A: Yes. Members may reserve the Private Dining Room, Conference Room or Banquet Room without a room rental fee.

Q: What is the Dress Code in the Clubhouse?

A: When dining in the Grill Room the dress attire is casual, although a few items are not acceptable. These include; ball caps, swimwear and athletic shorts. Jeans are permissible in the Grill Room, Panther Den and Main Dining Room (unless noted for a special event).

Q: What is the Dress Code on the golf course?

A: Shirts for men must have sleeves and collars and must be worn at all times on the golf course and practice area. Walking shorts (hemmed) with an out seam of at least sixteen inches are acceptable golf attire. Halter or tank tops are considered improper attire for ladies. Denim attire of any color is not considered acceptable golf course attire.

Q: When is my billing cycle?

A: All members are billed at the end of each calendar month. You can view your monthly bill by using your member log-in at www.panthercreekcc.com.

Q: Does Panther Creek Country Club offer direct payment?

A: Yes. Visit www.panthercreekcc.com and click on membership to download the enrollment form.

Q: Can I bring a guest to the Golf Course?

A: Of course! Weekday Green Fees \$55

Q: Can I bring a guest to the swimming pool?

A: Yes. All you need to do is fill out a guest slip at the check in station at the pool. There is a guest fee that is determined by the Pool & Tennis Committee each year. Please call the Business Office at 546-4431 for the current Pool Guest Fee.

Q: Who has access to the Fitness Center?

A: All Golf and Social members and dependents over 16 years of age have complimentary access to the fitness center. Contact the business office to get your access code! The fitness center is open 7 days a week from 4am-11pm.
